Teams: Competition is limited to the first 15 cooking teams for professionals and 12 teams for backyard cookers. There can be no more than four (4) persons on a team.

Cooking Instructions and Rules

- Professional Teams must follow Cook Team Rules found on the SCBA website at scbarbeque.com/cook-teams-rules
- Teams may prepare and cook the pork in any fashion they prefer so long as it is suitable to be served to the public.
- Teams must prepare the barbecue on site at H.Cooper Black Jr. Recreation Area. The meat will be furnished and will be available for pickup beginning at approximately 1:00 pm on Friday, September 5, 2025. Rib entry must bring their own ribs.
- Each team will be responsible for cooking a minimum of 8 butts averaging approximately 8 pounds each if professional and 2 butts if backyard cooker.
- Each team must supply their own ingredients, grill, tools, and all materials needed by the team.
- Teams are expected to serve their barbecue to the public from 11:00 am until 1:30 pm. Ruby Masonic Lodge will provide each team
 with the containers necessary to serve the barbecue to the public.
- Each team will have a total cooking area of approximately 30 x 30. No two-story structures are allowed, and no on-site expansion beyond the allotted area will be allowed. All belongings must be entirely contained within the allotted area. Water and 20 amps of electricity will be provided. If you need more than 20 amps, it must be requested in advance and there will be an additional fee.
 Requests will be fulfilled on a first-come-first serve basis and are limited.
- The teams may NOT sell food or beverages to the public. Under NO circumstances are alcoholic beverages to be distributed to the public
 by the teams.
- All teams are requested to respect the rights of others with special emphasis against loud music, profane language and infringement on adjoining sites.
- Teams are required to attend a meeting with the SCBA at 3:00 pm on Friday, September 5, 2025.
- . Teams must have gloves, chop the pork under cover, and have a hand washing station.

Judging and Awards

Blind judging will begin promptly at 10:00 am on Saturday, September 6, 2025. Judging will be conducted by the **South Carolina Barbecue Association (SCBA).** Participants have the opportunity to earn points toward the **Master Barbecue Award** competition sponsored by the SCBA. Winners will be announced and awards presented at 1:45 pm.

All teams are asked to clean up their assigned cooking areas and return the site to pre-competition conditions. **The area must be cleaned before 6:00 pm on Saturday, September 6, 2025.** The head cook will be the responsible party for fulfilling this requirement.
